


Figure 2.3 (Sheet 2 of 2) INTENSITY-FREQUENCY-DURATION CURVES AND HISTORIC RAINFALL








> CUMULATIVE RAINFALL HISTORIC STORM EVENTS




HYDROLOGIC MODEL LAYOUT







ADJUSTED PROBABILITY NEUTRAL BURST INITIAL LOSS VALUES





Figure 6.1 (Sheet 3 of 3) TUFLOW MODEL RESULTS 20% AEP









Figure 6.4 (Sheet 3 of 3) TUFLOW MODEL RESULTS 2% AEP










Figure 6.7 (Sheet 3 of 3) TUFLOW MODEL RESULTS 0.2% AEP


Figure 6.8 (Sheet 3 of 3) TUFLOW MODEL RESULTS PMF






DESIGN FLOOD EVENTS



STAGE HYDROGRAPHS DESIGN STORM EVENTS




Figure 6.13 (Sheet 3 of 3) FLOOD HAZARD VULNERABILITY CLASSIFICATION 0.2% AEP




Figure 6.18 (Sheet 1 of 3) HYDRAULIC CATEGORISATION OF FLOODPLAIN PMF



IMPACT OF INCREASED RAINFALL INTENSITIES ON EXTENT OF FLOODING 1% AEP











